**Previous Practice:** Preliminary invoices are distributed in late August/early September, based on the final participant registration numbers from the previous season. Reconciliations are completed at the end of the current season – March/April – with either additional invoicing (in the event that there were more registered participants during the season than the preliminary numbers) or a refund (in the event that there were less registered participants during the season than the preliminary numbers).

**New for 2020-21:** Insurance and Assessment Fees will be based on the numbers of active Registered Participants in the OHF as of October 31, 2020 (for the first programming block), December 15, 2020, January 15, 2021 and February 15, 2021 with a final reconciliation on April 30, 2021. December 15, January 15, February 15 and April 30 fees will be determined by the active Registered Participants less the previous active Registered Participants taking into account duplicates.
